Report by the Chief Executive and Director of Administration (on behalf of all officers concerned)  
on a proposal to create a new single small grants scheme

SUMMARY

The Council operates a wide range of grants funds which are aimed at making a significant contribution to the vibrancy of the Borough. Over 200 individual awards were made in 2013/14 supporting a spectrum of projects from the arts to youth initiatives and £718,500 is available for distribution in 2014/15.

A review has been completed of these various funds and recommendations are made to bring together constituent grant funds into a new Wandsworth Grant Fund to be administered by the Economic Development Office. The WGF will have two bidding rounds aligned with the current WBSF, with enhanced member oversight to all awards provided through a strengthened Grants Sub-Committee. The Council's website will be updated to provide much clearer and more consistent information on grant funds to local organisations, and signpost to other funds (e.g. local Trusts) not controlled by the council. The WGF will have an overarching and consistent set of award criteria, but evaluation and awards process will be designed such that the original priorities of the constituent grant pots are maintained.

The Director of Finance comments that the new WGF pot will have an estimated budget of £396,500 in 2015/16 which is the current approved allocation of grant within the remit of the new fund. The consolidation of the grants budget is supported in that it will enable a more consistent approach to grant making. The creation of the new fund will require a short term, 12 month resource within the EDO whilst processes are rationalised and standardised, estimated to cost £40,000. The cost of this will be met from overall Council budgets.

## RECOMMENDATIONS

1. The Finance and Corporate Resources Overview and Scrutiny Committee are recommended to support the recommendations set out in paragraph 2 of this report. If they approve any views, comments or recommendations on this report these will be reported to the Executive for their consideration.
2. The General Purposes Committee are recommended to:
  - (a) approve the creation of a new post of VCS grants development officer in the Administration Department's Economic Development Office for a fix term of one year to oversee the implementation of the new grants scheme.
3. The Executive is recommended to:
  - (a) agree the creation of a new Wandsworth Grant Fund (WGF) by the combining of all existing grant schemes (with the exception of Youth Opportunities Fund – YOF) from 1st April 2015, building on the processes in place for the WBSF and funded from within existing budgets;
  - (b) agree that the allocation of all grants, and all application in relation thereto, be considered by the Grants Sub-Committee for recommendation to the Executive;
  - (c) agree the proposed changes to the terms of reference of all the Overview and Scrutiny Committees as set out in paragraphs 27 to 28;
  - (d) agree that the membership of the Grants Overview and Scrutiny Sub-Committee be increased from six Members to eight (paragraph 31);
  - (e) note the proposed creation of a one-year fixed term post in the Economic Development Office to oversee the implementation of the new grants scheme; and,
  - (f) note that a further report will be submitted to this committee on the details for implementing the new scheme.

## INTRODUCTION

4. The Council approves a diverse range of voluntary and community grant funds which make a significant contribution to the vibrancy of the borough. Over 200 individual awards were made in 2013/14 supporting a spectrum of projects from the arts to youth initiatives and £718,500 is available for distribution in 2014/15. This includes £197,000 carried forward from the Wandsworth Big Society Fund in 2013/14.
5. Responsibility for allocating these funds rests with multiple divisions within several departments. Grants are allocated in different ways using a variety of criteria that reflect the intended purpose of each grant fund. Given recent changes to the structure of the Council and reductions in staffing resources, a review has been undertaken to identify how the task

of supporting organisations through such small grants can be done more effectively and efficiently, whilst ensuring that the level of support is not affected. The Administration Department's Policy Unit has undertaken this review, working with officers across the Council to ensure that their experience and expertise over many years of administering grants was taken fully into account.

6. A number of grant funds are covered by this review and full detail on each of them is provided in Appendix 1. In addition, there are a wide range of non-Council funds available to local groups, details of which are also provided in Appendix 1.

## GRANT BUDGETS

7. Budgets for the current year are shown below. These totals reflect the changes to the WBSF in the EDO review (Paper No. 14-185 to the Finance and Corporate Resources Overview and Scrutiny Committee (FCROSC) and the Executive in February 2014) where the budget for 2014/15 was reduced by £44,000 to £125,000 to better reflect historic grant activity whilst minimising the impact on grant allocations. In addition, Arts Grants budgets were reduced by £25,000 to £65,000 in January 2014.

8. The criteria for eligibility to receive funding from each of these Funds are set out in Appendix 2. Ensuring that all the funds on these schemes are allocated can be difficult. Schemes which operate multiple application windows each year are prone to underspend, even where the average grant awarded is small. This is often due to decisions on

applications being held pending further information and clarification. Efforts are made to help grant-aided projects proceed and the EDO, in consultation with Head of Audit, has recently introduced criteria for rescinding awards if no start has been made within six months of award. The funds available for YWS and YOF grants were almost fully disbursed in 2013/14. For the YOF, it is a requirement of grant that projects complete and that all grant is spent by February each year. For the YWS, it is a requirement that grants are spent by 31st March each year.

## REVIEW FINDINGS

9. The current arrangement of grant fund pots helps to maintain and develop strong links between the service and the Voluntary and Community sector (VCS). However, the review has identified several issues which, when examined together, imply that the Council's overall grants offer is not as efficient as it could be, both from the Council's and the VCS's perspective. These issues are summarised below:
- Information on available funds is scattered and uncoordinated. There is no single source of information on available grants. Information is widely scattered across the Council's website. Such links as exist are often to fairly old information. Officers involved in grants often do not themselves have a complete overview of wider grants activity;
  - Eligibility and award criteria vary. For example, most funds provide grants of up to £5,000, the exceptions being the YWS community grants (£500 minimum - £15,000 maximum) and the Cultural Capacity grants (£10,000 max) and Creative Communities (£3,000 max), Small Arts (£2,000) and Eco Grants (£2,500). The Wandsworth Eco Fund awards grants at a minimum of £40. Most grants are for specific time-limited projects not involving a continuing revenue commitment. The exception is the YWS fund which has been used to fund running costs for a number of youth clubs. In practice, the CYP fund has also funded projects on an on-going basis. The types of organisation that may be funded are set out in varying degrees of detail in each fund's list of criteria; WBSF, for example, refers to "constituted" organisations with annual incomes of under £100,000 but others generally refer to "voluntary organisations" without being more specific;
  - Number of grants rounds varies. This varies between 1 to 4 each year. The "success rate" of applicants varies considerably, as does the average level of grant awarded. Similar projects are often funded by WBSF and YOF but applicants to the former are twice as likely to succeed and, on average, receive just over half of the grant awarded under YOF;
  - Some evidence of overlap between grants' funds. WBSF, for example, funds a range of projects for young people, including arts projects, as well as a wide range of sports activity. Individual groups have made grant applications to both the WBSF and the Wandsworth Eco fund and awards from both funds to the same organisation have covered similar projects;
  - Member involvement in grant awards is inconsistent. Some grants are awarded by the Executive on the recommendation of the Grants Overview and Scrutiny Sub-

Committee, other via delegated authority to officers acting on behalf of the Executive without prior consultation under Standing Order No. 83, as applicable:

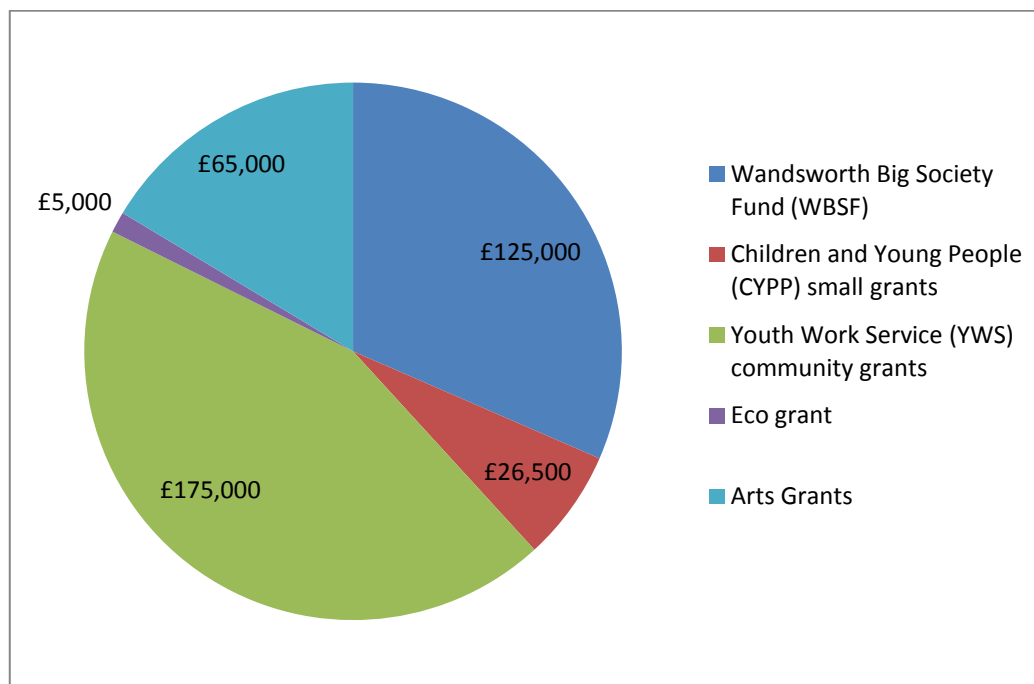
- The evaluation of outcomes, impact and learning is not consistent; and
- Relatively high administrative overheads. In general, the funds are aimed largely at smaller organisations needing relatively small amounts of money for specific purposes. Although small, each award must be assessed carefully and spent properly, i.e. following basic procurement rules such as the funded organisation obtaining competitive quotes before grant funds are released. This can mean a high administrative overhead relative to the amount of grant. This overhead varies with the varying number of grants rounds which are run.

### **REVIEW PROPOSAL – A NEW WANDSWORTH GRANT FUND (WGF)**

10. The overlap between grants funds has been noted above. An organisation may receive grants from several funds and may be pointed towards particular funds where officers feel they would have better prospects of success; this approach is inherently inefficient for the Council and possibly frustrating, and indeed confusing, for local groups. Awareness of some grants funds between departments is also not as good as it could be.
11. It is therefore proposed that the current grant funds are combined to create a single new Wandsworth Grant Fund (WGF) from 1st April 2015 which would provide grants of between £500 and £15,000. The grants would be awarded in two annual bidding rounds (June and November) to align with the current WBSF. A single bidding 'window' could be introduced but this is not recommended for a number of reasons, as follows:-
  - a) It allows groups to proceed with minimal delay, especially if urgent works are needed;
  - b) It spreads the administrative workload across the year rather than concentrating it in one period. This enables more help to be provided so as to improve the quality of applications and ensure proper assessment of applications; and,
  - c) It encourages groups to maintain contact with local councillors throughout the year rather than focus only on a single application period.
12. It is proposed that the YOF is excluded from the WGF. The YOF is considered a model of its type. The YOF is the major source of grant aimed specifically at the priorities of younger people, and young people themselves play an important role in deciding the awards which is a feature that would be difficult to preserve or replicate in the WGF model proposed here. Most of the awards are for arts, cultural or sports-related projects. As such, no change is recommended to this fund.
13. The YWS also gives maintenance grant aid to several voluntary sector youth clubs and these amounts are not included in the WGF pot above. However, work will be completed by the Youth Work Service to put these arrangements on a firmer footing. These grants includes; Devas Youth Club (£7,943); Caius House (£2,247) and Katherine Low Settlement (KLS) (£2,247). The Executive agreed (Paper 11-796) that, in line with the Council's

strategic aim to develop and maintain 'bigger, brighter' youth centres', these grants would remain in place when the YWS Grant scheme was set up. The grant to KLS will be redirected to Caius House when this is fully functioning in 2015. The Youth Service also pays 90% of the annual rent for two other voluntary sector groups based at Ashlone Wharf: Sea Cadets (total rent £26,150) and Wandsworth Youth River (total rent £22,000).

14. The WGF will have an estimated budget of £396,500 in 2015/16, which is the current approved allocation of grant within the remit of the new fund, and will be constituted as follows:-



15. It is proposed that Member-level oversight to grant awards from the new Fund should be strengthened in two key ways: firstly, by ensuring that each organisation making a bid secures endorsement/sponsorship by at least one ward Member; and secondly, by concentrating decision-making within the Grants Overview and Scrutiny Sub-Committee, subject to approval, of their recommendations by the Executive. Introducing this approach would require some revisions to the terms of reference of the Finance and Corporate Resources OSC as well as widening those of the Sub-Committee; it would also increase the Sub-Committee's business (although not meetings) but would have the advantage of providing high levels of transparency. The implications for this Committee and the Sub-Committee are discussed later in this report.

16. In summary, the new WGF would:-

- (a) Enhance Members' involvement and oversight in the process;
- (b) provide clarity both internally and externally, potentially encouraging projects which are potentially collaborative and multi-disciplinary;
- (c) improve ability to identify trends in applications and to provide more real time advice to local groups, ward members and organisations on where there are 'grant application gaps' – either geographically or by outcomes/objective;

- (d) help to promote better Value For Money (VFM) – trends of multiple bids have been noted in this review for items such as web development time, or sports equipment – bids like this could be combined to deliver the same outcome at a reduced cost;
- (e) allow for easier and more cost-effective communications to potential bidders, thereby potentially attracting a more diverse audience;
- (f) be more efficient to administer; and,
- (g) be easier to monitor than the current disparate arrangements, providing Members with a clearer understanding of the impact of the programme, and easier identification of areas which need reviewing.

17. It is proposed that an annual report on applications, awards, outcomes and spend be provided to Members by the EDO in a consistent format. A single report covering all grants funds would be produced in September each year and be placed in the members online library.

### **AIMS OF THE NEW WGF**

18. The creation of the new WGF is intended to help address the issues set out in paragraph 10 and deliver the benefits set out in paragraph 16. In doing so the expectation would be that grants from the WGF would be awarded to organisations in a way which reflects the constituent grants pots within the overall Fund, namely: Arts; Children and Young People; Youth Work Service; Wandsworth Eco; and Wandsworth Big Society. This is both in terms of the outcomes each Fund individually sought to achieve, and the amount of the original fund. These two factors would be designed into the awards process and marketing materials from the start.

### **IMPLEMENTING THE WGF**

19. It is proposed that the EDO expands its current role to incorporate administering the new WGF, building on the well developed processes that have been put in place for the WBSF. To this end it is proposed to establish a fixed term post of VCS Grants Development Officer for 1 year (funded from existing budgets) within the EDO to deliver the new fund, including processes and online marketing content. The post holder would be expected to work with relevant officers in departments to ensure that the design of the awards process still meets the original aims and objectives of the constituent funds. After one year, the this post will be reviewed by the Economic Development Officer in light of experience in administering the WGF. This may deliver an efficiency saving in 2016/17 once all the processes have been mainstreamed.

20. The design of a new web page which provides contact details and basic information on Council *and other* funds would be critical to its launch. This marketing should include YOF and those groups listed in Appendix 1 which are not controlled by the Council, i.e.

21. A range of measures would also be designed to make the administrative processes for a single pot more efficient whilst leaving the process flexible and responsive to groups applying for small grants. These would include -
- (a) having a consistent statement as to the types of organisations that can receive grants. WBSF is aimed at "properly constituted" bodies with an annual income of under £100,000. A single definition might not be wanted but each fund should have such a statement;
  - (b) guiding principles that the grants schemes will adhere to, such as value for money, procurement policies, wider community benefit, the role of volunteers, expectations about levels of matched funding and meeting Council priorities; and,
  - (c) a description of activities that cannot be supported, e.g. ones that have already been funded or are replicating existing services.
22. The EDO would establish an officer-level *WGF Development Group* to oversee the implementation. This Group would give managers currently responsible for the grants the opportunity to provide ongoing input and challenge into the process. The successful evaluation and awards of grants cannot happen without the input of expertise from officers in departments. For example, the Cultural Capacity, Project Arts and Small Arts pots are about supporting the best quality individuals and projects rather than a more general support for arts activity – as detailed in [Appendix 2](#). In this sense, advice needs to be given by those with the experience and expertise to identify the best quality applicants. As is the case with all grants, the Arts Team would continue to be called upon to provide expert evaluation input to the grant applications even if it were to become part of a Staff Mutual, but the award process itself would remain within the Council's decision making structures.
23. The EDO currently seeks expertise from across the Council in evaluating applications for funding from the WBSF. Strengthening this process would be critical to ensuring that the WGF continues to meet the objectives of its constituent funds.
24. It is likely that there will be calls on the WGF that would constitute an 'emergency' and which couldn't reasonably wait until the next bidding round. Such situations might include, but not limited to, where a local group requires some match funding as a prerequisite to accessing a large sum elsewhere, or where a group requires funding to bridge a gap that would otherwise result in the winding-up of an organisation or an event / service. It is proposed that amounts up to £1000 could be awarded under the Standing Order 83(a) process. These instances would be reported to the next Grants Sub-Committee.



## **CONSULTATION**

25. A draft of this paper was circulated to the VCS and their views will be reported back to the Committee and the Executive. In addition, if the proposals in this report are approved, the EDO will ensure that the VCS are engaged at appropriate stages in the design of the WGF.

## **EQUALITIES IMPACT ASSESSMENT**

26. The Equality Act 2010 requires that the Council when exercising its functions must have "due regard" to the need to eliminate discrimination, to advance equality of opportunity between persons who share a relevant protected characteristic and persons who do not share it and to foster good relations between persons who share a relevant protected characteristic and persons who do not share it. As such an Equality Impact Assessment (EIA) has been undertaken on the proposals in this paper. This EIA is attached as an appendix to this report. This EIA has identified no negative impact and has identified that having one source of information and one consistent approach could increase awareness of grant funding across local organisations leading to a more diversity in groups applying and receiving grants

## **TERMS OF REFERENCE OF OVERVIEW AND SCRUTINY COMMITTEES**

27. The terms of reference of OSCs include the following:-

(a) All OSCs except the Finance and Corporate Resources OSC:-

"Financial assistance to organisations, and performance and governance arrangements for all significant partnerships, with activities related to those of this Committee".; and

(b) Finance and Corporate Resources OSC:-

"Overall policies in connection with financial assistance to voluntary organisations, including London-wide and local organisations; financial assistance to organisations, and performance and governance arrangements for all significant partnerships, concerned with general advice giving, multi-purpose organisations and organisations not falling within the terms of reference of any other committee".

28. In order to reflect the proposed arrangements for replacing the various grant funds with a single Wandsworth Grants Fund (WGF) it is proposed that the OSCs' terms of reference be revised so that the OSCs continue to consider proposals for those grants which are effectively service contracts, whilst all other matters concerning financial assistance to organisations would transfer to the Finance and Corporate Resources OSC.

## **GRANTS OVERVIEW AND SCRUTINY SUB-COMMITTEE**

29. The terms of reference of the Grants OS Sub-Committee are as follows:-

"To consider applications for grant aid to voluntary and community organisations providing services to residents of the Borough, and to make recommendations to the Executive on funding amounts and the terms and conditions of these grants."

30. The current membership of the Sub-Committee is six Members (four Majority Party, two Opposition). The creation of a single grant fund would effectively remove grant awarding 'power' from the CS and the ECSOSCs (and all other OSCs) as described in paragraph 27-

28 above. Whilst it is not felt necessary to propose any change to the Sub-Committee's terms of reference, the Cabinet Member for Finance and Corporate Resources proposes that their membership should be increased to reflect the proposals to bring the various other funding streams into one WGF.

31. It is therefore recommended to increase the Sub-Committee by 2 Members (to 8 Members). An increase of two members will enable the Sub-Committee to include an additional Majority and Minority Party Member - this would allow both parties to have members drawn for the present members on the FCROSC, Educ. & Children's Services OSC and the Community Services OSC, i.e. the key OSCs involved in grant awards.

#### **COMMENT FROM THE HEAD OF HUMAN RESOURCES**

32. The Head of Human Resources comments this will increase the Economic Development Office establishment by 1FTE for a fixed-term period of one year. Any extension beyond one year will require further separate approval.
33. The grade of the new post will be determined in accordance with the Council's approved Job Evaluation procedure and recruitment would be via the usual Council recruitment processes. Where the Council has suitable redeployees they will be given prior consideration.

#### **CONSULTATION**

34. The Staff Side have been consulted on this report and any comments received from them will be reported to the Finance and Corporate Resources OSC.

#### **DIRECTOR OF FINANCE COMMENTS**

35. The Director of Finance comments that the current grant budget is £718,500 in 2014/15. Excluding the carry forward from 2013/14, the new WGF pot will have a budget of £396,500 in 2015/16 which is the current approved allocation of grant within the remit of the new fund. The consolidation of the grants budget is supported in that it will enable a more consistent approach to grant making. Departments will still be able to advise on the suitability of grant bids but there will be additional Member scrutiny of applications, more consistency across awards and less risk of duplication. The creation of the new fund will require a short term, 12 month resource within the EDO estimated to cost £40,000 whilst processes are rationalised and standardised. The cost of this will be met from overall council budgets.

#### **CONCLUSION**

36. In centralising the current range of grants funds operated by the council this review seeks to create a more transparent, efficient and coordinated approach. In doing so it ensures that the council continues to provide support to the wide range of voluntary and community organisation whose work helps maintain and promote the vitality of the borough.

The Council operates a wide range of grants funds which are aimed at making a significant contribution to the vibrancy of the Borough. A review has been completed of these various funds and recommendations are made to bring together constituent grant funds into a new Wandsworth Grant Fund to be administered by the Economic Development Office.	
<b>2. What is the rationale behind these changes?</b>	
The consolidation of the grants budget will enable a more consistent approach to grant making. For applicants this means there will be one source of information regarding grants, which will ensure that they do not miss any potential grant sources and clarity of dates of funding rounds, ensuring that applicants can build these into their annual planning cycles.
